After tax credits have been reserved to all Workforce Housing, Special Tier I and Tier I applicants, the non-profit sponsors have until November 1, 2007 to provide business firm commitment letters to CHFA. If uncommitted tax credits are available after November 1, 2007, the highest scoring Tier II applicants will have until December 1, 2007 to secure commitment letters from eligible business firms. After December 1, 2007, CHFA will reserve any remaining credits to the next highest scoring Tier II applicants who have obtained commitment letters from eligible business firms.
