Ms. DeWyngaert called the meeting to order at 1:01 p.m. A roll call of committee members was conducted and a quorum was present.

Ms. Simonelli presented the resolution authorizing approval of tax-exempt bond financing in an amount not to exceed \$40,300,000 consisting of a construction loan of approximately \$21,000,000 and a permanent loan of approximately \$19,200,000 as well as subordinate mortgage financing of up to \$1,000,000 in CHFA Opportunity Funds for MLK Apartments, located in Hartford, Connecticut.

Upon a motion made by Mr. Ugalde, seconded by Ms. Clarke, the Mortgage Committee members voted by roll call and were unanimously in favor of recommending the resolution for financing of MLK Apartments, located in Hartford, Connecticut, to the Board of Directors for consideration.

Mr. Norris presented the resolution authorizing approval of taxable bond proceeds for a permanent-only first mortgage loan of up to \$3,000,000 and a construction-to-permanent second mortgage of up to \$1,000,000 in CHFA Opportunity Funds for Oak Woods Apartments, located in Terryville, Connecticut. Discussion followed. It was requested that staff provide the definition of "at risk of homelessness".

Upon a motion made by Ms. Tepper Bates, seconded by Mr. Ugalde, the Mortgage Committee members voted by roll call and were unanimously in favor of recommending the resolution for financing of Oak Woods Apartments, located in Terryville, Connecticut, to the Board of Directors for consideration.

Ms. DeWyngaert asked Mortgage Committee members to consider the minutes from the October 24, 2023 meeting.

Upon a motion made by Mr. Ugalde, seconded by Ms. Tepper Bates, the Mortgage Committee members voted by roll call and were unanimously in favor of approving the October 24, 2023 Mortgage Committee minutes.

Ms. Giordano summarized the Homeownership Report through October including information previously requested by the committee on CHFA's single family delinquencies and foreclosures.

Ms. Malani provided a summary of multifamily activities for the month of October. The Chair requested that future reports include a year over year comparison of total units developed. Staff was also asked to provide a report on the status of the State-Sponsored Housing Portfolio including what we are doing with the portfolio going forward.

There being no further business to discuss, upon a motion made by Mr. Ugalde, seconded by Ms. Tepper Bates, the meeting adjourned by unanimous consent at 2:00 p.m.
