"(NEW) Wind Load Diagram: For projects entailing roof installations, and new windows, a wind load diagram must be provided by the Structural engineer. Minimum performance product data for roof and openings assemblies shall include performance data indicating that uplift and other wind load criteria meet or exceed the loads listed on the Wind Load Diagram.

(NEW) Provide window elevation diagrams for all window instance types indicating dimensions, square footages, and the dimension from finish floor to top of sill.

(NEW) Confirm acceptability per current code for interior sill heights from finish floor to top of sill, and clear."

Answer: The items mentioned above are not required.

Question: Should responses include location specific pricing?

Answer: As indicated in paragraph 8 of the RFP, you may provide the "rate or range of rates" or "You may quote a flat fee for all services . . ."

Question: Are exhibits included in the maximum page limit for responses?

Answer: Maximum page limit is exclusive of any of the required exhibits or attachments.

Question: The RFP lists approximately 48 permanent supportive housing developments under various supportive housing initiative programs. The total number of units in the portfolio is approximately 1,168. Will the selected vendor(s) be able to use sampling of a certain percentage of units or should the site visits include all units at all locations?
