

CHFA 288-Request for Proposals (“RFP”)—Information Technology Resource Provisioning for Application Modernization and Business Intelligence Deployment—Questions and Answers as of July 11, 2025:

Is there a specific template or format required for submitting the cost proposal, or may we provide our own structured table that meets the stated requirements? Or do we submit another proposal document for it?

CHFA does not require a specific format for submitting the cost proposal but would like costs broken out as specified in the RFP.

Are respondents required to sign and notarize Exhibit C as part of the submission package, or is acknowledgment via the signed Exhibit A sufficient at this stage?

Respondents are required to sign, notarize and include Exhibit C as part of the submission package.

What is the annual amount spent for the previous year on this project?

This is a new project.

If this is a new contract, what is the annual budget for this contract?

CHFA does not have a specific budget for this project.

Will CHFA consider a hybrid delivery model with a mix of offshore and onshore resources?

CHFA will consider a hybrid delivery model with a mix of offshore and onshore resources.

Will the work be onsite or remote?

The work may be a combination of onsite and offsite.

Will CHFA consider an extension to submit a proposal?

All proposals must be submitted on or before the deadline indicated in the RFP, with no exceptions.

The RFP states on page 3 in the “Team Composition and Flexibility” section that it will include “Enterprise BI Reporting Expert.” However, in the next section for ‘Specific Role Requirements,” it does not list the Business Intelligence role or qualifications. Please clarify.

Firms can include roles related to Data Warehousing.

The RFP states “Demonstrated domain knowledge in financial systems and reporting will be a key evaluation factor.” “At least three references for similar projects completed within the past five years, preferably for financial organizations. Additionally, please include as references any other State of Connecticut agencies or departments that have engaged your firm to perform services.” If a firm has references from other state agencies which are of the same size, but not from financial systems or any other state agencies or departments, will that satisfy the requirement or will scoring be impacted?

Firms will be evaluated by the criteria listed in the RFP.

Can firms assume that while experience in the financial sector is preferred, references from other domains or industries — including non-financial, quasi-public, or state agencies — are also acceptable?

In addition to including as references other State of Connecticut agencies and departments, firms responding should include other references for similar projects completed within the past five years. Firm must use its own discretion when providing references.

Are resumes part of the page limit? Do resumes only have to be provided for Project Manager, Business Analyst(s), Software Developers, Enterprise BI Reporting Expert, Quality Assurance Tester and Database Administrator.

Are resumes required at the time of proposal submission, or will they be requested post-award or on demand?

- a. The RFP outlines several roles (e.g., Project Manager, Business Analyst, Software Developers, etc.). Could CHFA please confirm whether we are required to submit resumes for each of these roles as part of the proposal?
- b. Are offshore resumes required at the proposal stage, or only onsite/onshore?
- c. For roles such as “multiple software developers,” how many profiles should we include at this stage? Would one representative profile per role suffice, or are multiple profiles expected for certain roles?

Resumes are not included as part of the page limit. Resumes should be submitted at the time of response. Please use discretion when providing multiple resumes for the same position.

Please confirm if the nature of the contract will be a traditional staff augmentation model, a project outcome-based model, or a combination of the two.

The team is intended to be used for project outcome based.

Can CHFA provide the name of the current supplier, the pricing and proposals? When was the existing contract started, and what is the annual monetary spend value? Are there any issues with the current firm? Are incumbents allowed to bid?

This is a new project, and therefore none of the questions above are applicable.

What is the estimated annual budget for this project?

CHFA does not have an estimated annual budget for the project.

Under Section 1. Firm Information, please clarify what “size” means?

Please include the number of employees, how many offices, and any other relevant information about the firm.

Under section 2. Qualifications, firms are required to provide resumes of proposed team members. Could CHFA please clarify if the resumes requested have to be actual resumes?

Firms may provide pertinent information about team members in lieu of actual resumes.

If firms must present actual candidates, can these be replaced by equally or better-qualified candidates if they are no longer available at the time of contract award?

CHFA is not seeking temporary personnel under this RFP. If certain team members are not available at the time of contract award, CHFA will consider how to proceed at that time.

Is CHFA looking for firms to source, vet, screen, and recruit the requested positions from the market, or for firms to provide their in-house personnel to perform the services?

CHFA does not want firms to source, vet, seek and recruit the requested positions from the market.

Are firms required to provide a live resume for each of the positions under the section Team Composition and Flexibility?

Firms may provide pertinent information about team members for each of the positions in lieu of live resumes.

In the event firms are suggesting a team of people at the time of proposal submission, could CHFA please clarify if firms are allowed to add more and new team members at a Task Order level if they are not included along with proposal submission?

Firms may make minor changes depending on the roles and demand required.

If firms are required to submit proposed team members and their resumes with the proposal, could CHFA please clarify whether firms are allowed to add more personnel at the Task Order level after contract award, taking into consideration the required roles are based on demand? What roles are expected to be deployed immediately upon contract award, and which resources will be phased based on project needs?

At this time, CHFA is unable to provide the requested information. Please refer to the RFP document for the information currently available to assist in the preparation of your proposal.

The RFP states on page 3 in the “Team Composition and Flexibility” section that it will include “Enterprise BI Reporting Expert.” However, in the next section for “Specific Role Requirements,” it does not list the Business Intelligence role or qualifications. Please clarify.

Firms can include roles related to Data Warehousing.

Under section Team Composition and Flexibility, the following is stated: "The firm must demonstrate the ability to scale the team up or down with reasonable advance notice based on project needs. Flexibility in resourcing should be a key offering to accommodate project demands efficiently." Could CHFA please clarify if firms are allowed to provide any information regarding this? If so, where in the proposal response should it be attached?

Firms may add any information that may be helpful to CHFA in making a decision. There is no specific requirement regarding where to add such information in the response.

Under section 3. Technical Proposal, the following is stated: "Detailed approach and methodology for completing the scope of work." Can you please let firms know what information CHFA is looking for in Methodology and what information CHFA is looking for in Approach?

CHFA cannot provide any more information on the methodology or approach. Firms may suggest to CHFA how to accomplish the objectives in the RFP.

Under section 3. Technical Proposal, CHFA is requesting the approach in the first and second points. Could CHFA please clarify in which of the two points firms should provide their approach, or if firms are allowed to do a cross-reference between these sections?

CHFA does not have a preference on how firms should respond.

Could CHFA please clarify if responses to section 3. Technical proposal must include a point-by-point response to the section Scope of Services, including a detailed response to each of the pointers included under Software enhancement, Data Warehouse Design and Integration, and Business Intelligence Implementation?

CHFA does not have a preference on how firms should respond.

Could CHFA please clarify whether any of the requirements outlined in Section 2: Qualifications may be satisfied through the use of a subcontractor?

CHFA does not typically allow subcontracting.

Are the hourly rates requested all-inclusive hourly (bill) rates?

Hourly rates should be all-inclusive.

Are firms allowed to provide hourly rate ranges?

Firms may provide hourly rate ranges.

Are firms required to provide pricing for the three locations (onsite, remote, offshore) to each of the roles in order to be responsive?

Firms do not have to provide rates for all three locations (onsite, remote and offshore).

Could CHFA please confirm whether firms may provide a single rate allocation per role and still be considered responsive? For example, would it be acceptable to submit only an hourly rate for a Remote Project Manager, without including separate rates for onsite or offshore options?

Firms can provide a single rate allocation if desired.

Could CHFA please clarify whether firms are required to submit in order to be responsive separate resumes for each proposed allocation type (one for onsite, one for remote, and one for offshore) for each given role required by CHFA?

Resumes or information about personnel should be provided for anyone who would be assigned to work for CHFA regardless of whether onsite, remote or offshore.

Are firms required to provide health benefits? If so, will firms be reimbursed for this expense? Are firms required to pay Holidays, PTO, Sick Leaves, etc., to the consultants placed? If so, will firms be reimbursed for this expense?

Firms must follow all applicable state and federal laws and regulations. CHFA will not reimburse firms for any expenses related to following state and federal regulations.

Is there any percentage limitation to the yearly increase that firms should be aware of?

There are no limitations to disclose.

Can firms provide commercial references?

Please refer to the RFP for guidance on references.

Can firms also use their subcontractors' references to meet the reference requirements listed in this solicitation?

Subcontractors are generally not allowed.

Can firms provide references from former clients, or are they required to provide references exclusively from current clients?

References do not have to be existing current clients.

In the event that firms are subcontracting, could CHFA please confirm if the subcontractor can bid as a prime vendor, too? In the event that firms are subcontracting, could CHFA please confirm if the subcontractor can subcontract with several primes, too?

Subcontracting is generally not allowed.

Under section Requested Information, the following is stated: "10. Describe your presence in Connecticut, if any. Also include any participation by your company in any civic or other non-profit activities, including any contributions that your company made." Are firms allowed to provide information from their subcontractors?

Subcontracting is generally not allowed.

Could CHFA please clarify whether vendors are required to have prior experience working with financial organizations in order to be considered for this opportunity? Please clarify what type of financial systems vendors should have experience with.

In addition to other evaluation criteria, firms will be evaluated based on experience requested in the RFP.

Regarding the section titled "Specific Role Requirements," could CHFA please confirm whether vendors must propose consultants for each listed role and meet all qualifications described in each position?

Responses will be evaluated based on the criteria listed in the RFP.

Could CHFA please confirm whether a Certificate of Insurance (COI) is required to be submitted with the proposal response, or only upon award?

A certificate of insurance is not required at this time. However, selected firm(s) will be required to provide a COI at or before execution of a contract.

Could CHFA please confirm whether vendors who have not made any contributions are allowed to enter "N/A" in OPM Form 1?

Yes, please write in N/A if no contributions were made.

Could CHFA please confirm if vendors have to include the whole response, forms, and pricing as a single PDF document?

Please submit responses as a single PDF if within the allowable size limit. If not, responses can be broken into separate PDFs and sent separately.

Could vendors apply to one specific category, or is it a requirement to apply to all categories?

Firms should respond to the full RFP.

Are electronic signatures allowed? Do the attach exhibits have to be notarized?

Electronic signatures cannot be used for notarized documents. Documents that require notarization, must be notarized.

Could CHFA please provide clarification on the appropriate section within the response where vendors should include the forms?

Forms can be attached at the end of the submission.

If a vendor exhausts their assigned budget, can the purchase order (PO) be extended with additional funds?

This question cannot be answered at this time since there is currently no specific budget.

How many departments will benefit from the MSA? Could CHFA please share the list of those departments?

The RFP is only related to CHFA and no other departments.

Through which platform or method will task orders be issued and communications shared (e.g., via email or a specific portal)?

There is no specific portal at this time for communications.

Could CHFA please clarify what the section in the evaluation criteria, “Cost, including the firm’s willingness to provide price protection” means? Specifically, do vendors have to provide their pricing as protected or fixed for a certain period of time?
