REQUEST FOR PROPOSALS FOR SWAP, DERIVATIVE AND INVESTMENT VALUATION SERVICES GASB COMPLIANCE

January 24, 2020

I. Background

The Connecticut Housing Finance Authority (the "Authority" or "CHFA") was created in 1969 by the State Legislature, as a public instrumentality and political subdivision of the State of Connecticut for the purpose of increasing the supply of and encouraging and assisting in the purchase, development, and construction of housing for low and moderate income families and persons throughout the State. CHFA's stated mission is to help alleviate the shortage of affordable housing for low and moderate income families and persons in Connecticut, and when appropriate, to promote or maintain the economic development of the State through employer-assisted housing.

II. Proposed Scope of Services (the "Services") The Authority is requesting Proposals (the "RFP") from qualified firms (the "Firms") who are interested in becoming a provider (the "Provider") of valuation services in connection with existing and outstanding derivative instruments including swaps and investments including bonds held by the Authority for purposes of complying with the Authority's reporting requirements.

The duties of the Provider shall include, but not be limited to:

- 1. Produce monthly derivative valuation report. The information must include or satisfy:
 - a. Mark-to-market value
 - b. Fair value
 - c. Option value
 - d. Accrued interest
 - e. Other relevant data
- 2. Produce annually derivative and investment valuation reports. The information must include or satisfy:
 - a. Information referenced under II(1) above, as applicable.
 - b. Measurement and effectiveness based on GASB or other industry standards as required or applicable including, but not limited to:
 - i. GASB 53
 - ii. GASB 72

- 3. Produce and maintain the swap exposure table (the "Swap Table") for the Authority's bond Official Statements.
- 4. Notify the Authority of any rating changes relating to the derivative counterparties.

The proposed engagement will be for a period no longer than three years and it is expected to begin July 1, 2020.

Since its inception, the Authority has issued over \$19 billion of tax exempt and taxable bonds of which proceeds from the bonds were used to purchase single family loans and make multifamily loans. Over the next three years, the Authority expects to issue \$1 billion to \$2 billion of Housing Mortgage Finance Program Bonds, a portion of which as variable rate bonds. As of December 31, 2019, the Authority has 39 swaps with notional outstanding of approximately \$901 million. None of the Authority's swaps qualifies under the Consistent Critical Terms (the "CCT") method. III. Evaluation Criteria

Firms will generally be considered on the basis of their response to this RFP, additional written information as requested by CHFA, face to face and oral interviews, if any, against the following criteria:

- 1. Reputation and experience of the Firm
- 2. Responsiveness to CHFA's needs
- 3. Experience with the State Housing Finance Agencies (the "HFAs")
- 4. Experience with GASB reporting compliance
- 5. Competitiveness of proposed cost
- 6. Software capabilities to provide the requested Services
- 7. Financial capability to provide the requested Services and overall financial stability
- 8. Commitment to Connecticut

IV. Requested Information

Each respondent to the RFP must provide the following information:

- 1. A brief description of your firm in providing the Services as described in this RFP.
- 2. Indicate the total number of staff in your firm and the number of staff that you expect to assign to this engagement. Please list those people with their résumés. What are their other responsibilities?
- 3. Describe your firm's experience with HFAs. Which HFAs (or other similarly sized clients) do you represent and provide similar Services? Provide three (3) references with names, phone numbers and email addresses. Please also include any other State of Connecticut agencies or departments that have engaged your firm to perform similar Services.

- 4. Describe the Services including the methodology behind it, you will be providing to the Authority. List, in order, what you think are the four most important functions you would perform for the Authority.
- 5. Describe any services your firm performs for other Connecticut clients or any other connections or commitments that it has in Connecticut.
- 6. What is the most important question that we haven't asked you? Why should the Authority hire you instead of some other firm?
- 7. Describe any and all material lawsuits, legal or administrative proceedings or governmental investigations, criminal actions or law enforcement activities (including those by federal, state or local authorities, or self-regulatory organizations) or non-routine SEC, MSRB, or other regulatory bodies' inquiries or investigations relating to your firm, including any proceedings to which your firm or any of their respective officers, directors or employees is a named party or of which any of such has been the focus, that have occurred in the last three (3) years or that are currently threatened, including whether your firm, or their respective officers, directors or employees have been censured by any regulatory body. Please summarize any reporting that your firm has made to the SEC, MSRB or any regulatory bodies over the past three years in connection with your public finance activities.
- 8. Describe whether you foresee any potential conflicts of interest arising from an engagement with the Authority for the Services. If so, please describe how your firm would address potential conflicts of interest.
- 9. Has your firm ever been removed from an account prior to the expiration of its contract (i.e., been fired)? If so, please explain. If you wish, list the name of a third party with whom the Authority could discuss this termination.
- 10. Provide a fixed or flat rate fee based upon the Services as described in this RFP and assumptions set forth in (a) and (b) below. If your firm would like to suggest an alternative fee structure such as hourly rates, please provide the hourly rates of the individuals assigned to the engagement. Provide the estimated hours for each Service to allow the Authority to compute the cost of the applicable services. Indicate whether there is a cap or not-to-exceed fee for each Service. If a breakdown is necessary to reflect different Services, please provide such information. Additionally, provide hourly fees charged for other analysis and ad hoc analysis.
 - a) Assume the Authority procures between 3 and 4 new non CCT swaps each year.
 - b) Assume the Authority requires at least one (December 31) measurement and effectiveness tests pursuant to GASB.

- 11. Furnish evidence of the firm's financial stability.
- 12. Furnish evidence of the firm's current professional liability insurance in the amount listed in Exhibit A.
- 13. Furnish evidence the firm and its employees related to this engagement are registered with the applicable regulatory bodies and are in compliance as required by securities law or regulation, if applicable.
- 14. Provide evidence that your firm is registered with the Connecticut Secretary of State's Office. If your firm currently is not registered with the Connecticut Secretary of State, please indicate whether your firm will so register if your firm is awarded this contract.
- 15. Submit specific information regarding your firm's commitment to Affirmative Action. Please include at a minimum formal internal hiring practices and discussion of working relationships with women and minority owned companies. Please include your firm's most recent EEOC report.
- 16. Describe your presence in Connecticut, if any. Also include any participation by your firm in any civic or other non-profit activities, including any contributions that your firm made.
- 17. An authorized signatory of the firm submitting a proposal shall execute and submit with your proposal submission the attached certification regarding Connecticut General Statutes (CGS) §4-250 and §4-252a (attached as Exhibit B). In addition, selected firms must comply with all state and federal laws applicable to CHFA including, but not limited to, ethics laws, requirements, and procedures, and must execute the attached Statutory Provisions, certifications and affidavits if selected to contract with CHFA (attached for informational purposes as Exhibit C).

V. Submission Deadline

Responses to this RFP must be received by the Authority no later than **12:00 noon, March 6**, **2020.**

VI. Submission Requirements

- 1. Please limit your response to 10 pages, exclusive of a cover letter and exhibits.
- 2. Three (3) originals, along with a CD containing a copy of the proposal in PDF format, should be delivered in a **sealed envelope** to:

3. Proposals received after the Submission Deadline date and time may result in the CHFA's rejection of the Proposal.

4. Proposals must include a cover letter signed by an individual authorized to enter into a contract with the CHFA on behalf of the organization, acknowledging that the firm agrees to be bound by all terms and conditions of the RFP and affirming that all information contained in the Proposal is true and accurately portrays all aspects of the services to be provided.

VII. General Instructions

- 1. Firms can submit questions to the Authority for clarifications or for more information. Questions must be received by the Authority on or before February 21, 2020. The Authority reserves the right to answer or not to answer a question. If the Authority decides to answer a question, the answer will be posted on the Authority's website. All questions or requests for further information should be directed to Hazim Taib by emailing to hazim.taib@chfa.org and faxed to (860) 257-8375. Any other ex parte communication regarding this RFP with any Members of the Board or staff of the Authority is NOT permitted and may be grounds for elimination from further consideration.
- 2. Contained in this RFP is the Swap Table as of December 31, 2019 and a list of CHFA's bond investments.
- 3. Failure to comply with the requirements of this RFP may result in CHFA's rejection of a Proposal.
- 4. Securities firms or swap dealers or any firm that engages in underwriting securities or in providing swaps will not be considered.
- 5. No joint venture or subcontractors will be acceptable. The Authority requires all Services to be provided by a single firm.
- 6. CHFA shall not be liable for any pre-contract costs incurred by any organization participating in the selection process.
- 7. All matters set forth in a Proposal shall become the property of CHFA, are matters of public record, and may be disclosed by CHFA after the awarding of the contract. The contents of each Proposal will be available for public inspection after the awarding of a contract.
- 8. CHFA is exempt from the payment of excise and sales taxes imposed by the Federal Government and/or the State. Proposers remain liable, however, for any other applicable taxes.
- 9. CHFA reserves the right, in its sole discretion to: reject any and all Proposals received in response to this request; negotiate the fees and charges contained in any Proposal, and is not obligated to accept a Proposal based upon the lowest fee schedule; accept a Proposal based on considerations other than costs; accept multiple Proposals based on capabilities; waive or modify any irregularities or

informalities in Proposals received; award contracts in any manner necessary to serve the best interest of the CHFA and request additional information as determined necessary.

- 10. Firms should also be aware of the following:
 - a) The agreement between CHFA and the selected organization will be evidenced by a written engagement letter (the "Contract"), which shall incorporate this RFP, the Proposal and any related correspondence. In executing such Contract, the selected organization agrees to be bound by the terms and conditions of this RFP, and that all representations, warranties and commitments in the Proposal and related correspondence are contractual obligations. In the event of any conflict in the terms and conditions between the RFP, Proposal and any related correspondence, the RFP shall control.
 - b) Any work product issued or produced for CHFA belongs to CHFA. CHFA shall not be required to seek approval(s) from the Firm for the use of such work product (for the benefit of CHFA and its business activities).
 - c) The Authority reserves the right to conduct additional, separate RFP processes to procure the services of entities with additional, special or distinctive qualifications, if the Authority determines that it needs these additional services. If the Firm can no longer provide the Services as contemplated herein, or through merger, consolidation, change of business purpose, or otherwise changes form, the Authority, in its sole discretion, and upon its determination that such action is in the best interest of the Authority, reserves the right to retain such Firm, retain the surviving entity or replace such Firm with an Approved Firm (the "Substitute Firm"); provided, however, that any Substitute Firm shall serve for only the remainder of the term to be served by the Firm contemplated herein.

Instructions: CHFA Insurance Requirements

All contractors and vendors are required to provide proof of the required insurance coverage before entering the premises or commencing any work at any CHFA facility. Contractors and vendors must obtain, at their own expense, all the insurance required here, and acceptable evidence of such insurance must be properly furnished to, and approved by, CHFA.

All subcontractors are subject to the same requirements. It is the responsibility of the primary contractor or vendor to obtain acceptable evidence of insurance from subcontractors.

CHFA also requires that they be named as an additional insured on your general liability policy(ies). Your general liability policy must be endorsed with ISO Endorsement CG 20 10 (or equivalent) *or* ISO Endorsement CG 20 26 (or equivalent), *and* ISO Endorsement CG 20 37 (or equivalent) if so required. These form numbers must be specifically referenced on the certificate of insurance. If your insurance company uses a different form to provide CHFA with additional insured status on your policies, copies of those forms must be provided in advance with the insurance certificate for review and approval by CHFA. All coverage must be primary as to CHFA.

The proper name for the entity to be named as additional insured is: "Connecticut Housing Finance Authority, and/or related or affiliated entities."

Evidence of compliance with these requirements is with the ACCORD form 25, "Certificate of Liability Insurance", with 30 day notice of cancellation, plus copies of any required additional insured endorsements. Current insurance certificates must be furnished to CHFA at all times. Replacement certificates must be furnished *prior to the expiration or replacement* of referenced policies.

Insurance Requirements for Contractors or Vendors

Insurance Requirements

Contractors or vendors working for and/or doing business with the Connecticut Housing Finance Authority (CHFA), or using CHFA facilities, shall agree as a condition of acceptance to furnish and perpetually maintain, at their own expense, for the duration of any project, work, contract or use of CHFA facilities the following policies of insurance covering the following items. Insurance must be primary and endorsed to be noncontributory by CHFA, must be written in an insurance company A.M. Best rated as "A-VII" or better, and CHFA must be endorsed to the policy as an additional insured (except Worker's Compensation) unless this requirement is specifically waived in writing by CHFA. Contractors further agree that any subcontractor they intend to use on CHFA assigned work will be required to submit to the same indemnity and insurance requirements contained in this schedule. Contractor shall obtain insurance certificates stating that both Contractor and CHFA shall be endorsed to the subcontractor's insurance policies as additional insured.

Indemnification

The contractor/vendor shall save harmless, indemnify, and in the event of claim, notification or suit will immediately defend CHFA and any related or subsidiary entities, their officers, employees and volunteers, from and against all loss, costs, damage, expense, claims or demands arising out of or caused or alleged to have been caused in any manner by the performance of work or use of facilities herein provided, including all suits, claims or actions of every kind or description brought against the CHFA either individually or jointly with the entity or organization for or on the account of any damage or injury to any person or persons or property, including the entity or organization's employees or their property, caused or occasioned, or alleged to have been caused or occasioned in whole or in part by the entity or organization, including any subcontractor, their employees or agents.

Certificates of Insurance

Before starting any work, or commencing any use or occupancy of CHFA premises, the contractor or vendor shall furnish to CHFA a certificate of insurance indicating, specifically, the existence of those coverages and limits set forth as follows. CHFA must be named on the insurance certificate as "additional insured" for the coverage's afforded, and a copy of the actual policy endorsement that adds CHFA as an additional insured must be attached to the certificate (Blanket additional insured endorsements are deemed acceptable). It is also the duty of contractor or vendor to provide renewal or replacement certificates and endorsements to CHFA upon renewal or new placement of any insurance policy which may expire or renew during the term of any project or engagement, and to give CHFA thirty (30) days notice of any cancellation or change in the terms of such policy or policies during the periods of coverage. Upon request of CHFA, the contractor or vendor shall furnish to CHFA for its examination and approval such policies of insurance with all endorsements, or copies thereof, certified by the agent of the insurance company.

CERTIFICATION REGARDING CONNECTICUT GENERAL STATUTES § 4-250 Gift and Campaign Contribution Certification (for contracts valued at \$50,000 or more in a calendar or fiscal year)

Contractor hereby swears as true to the best knowledge and belief of the person signing below

(1) That no gifts were made by (A) the Contractor, (B) any principals and key personnel of the Contractor, who participate substantially in preparing bids, proposals or negotiating state Contracts, or (C) any agent of the Contractor or principals and key personnel, who participate substantially in preparing bids, proposals or negotiating state Contracts to (i) any public official or employee of CHFA soliciting bids or proposals for the Contract, who participates substantially in preparation of bid solicitations or requests for proposals for the Contract or the negotiation or award of the Contract, or (ii) any public official or state employee of any other state agency who has supervisory or appointing authority over CHFA;

(2) That no such principals and key personnel of the Contractor or agent of the Contractor or principals and key personnel, knows of any action by the Contractor to circumvent such prohibition on gifts by providing for any other principals and key personnel, official, employee or agent of the Contractor to provide a gift to any such public official or state employee; and

(3) That the Contractor is submitting bids or proposals without fraud or collusion with any person.

Any bidder or proposer that does not make the certification required under (1) through (3) above shall be disqualified and CHFA shall award the contract to the next highest ranked proposer or the next lowest responsible qualified bidder or seek new bids or proposals.

(4) Contractor further swears and attests that the following are all contributions made by principals and key personnel of the Contractor to campaigns of candidates for state-wide public office or the General Assembly of the State of Connecticut:

No state contractor, prospective state contractor, principal of a state contractor or principal of a prospective state contractor, with regard to a state contract or state contract solicitation with or from a state agency in the executive branch or a quasi-public agency or a holder, or principal of a holder, of a valid prequalification certificate, shall make a contribution to (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of Governor, Lieutenant Covernor, Attorney General, State Comptroller, Secretary of the State or State Treasurer, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee (which includes town committees).

In addition, no holder or principal of a holder of a valid prequalification certificate shall make a contribution to (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of state senator or state representative, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee.

On and after January 1, 2011, no state contractor, prospective state contractor, procipal of a state contractor or principal of a prospective state contractor, with regard to a state contract or state contract solicitation with or from a state agency in the executive branch or a quasipublic agency or a holder, or principal of a holder of a valid prequalification conficted, shall **knowingly** *solicit* contributions from the state contractor's or prospective state contractor's employees or from a *subcontractor* or *principals of the subcontractor* on behalf of (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of Governor, Lieutenant Governor, Attorney General, State Comptroller, Secretary of the state or State Treasurer, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee.

<u>**Civil penalties**</u>—Up to \$2,000 or twice the amount of the prohibited contribution, whichever is greater, against a principal or a contractor. Any state contractor or prospective state contractor which fails to make reasonable efforts to comply with the provisions requiring notice to its principals of these prohibitions and the possible consequences of their violations may also be subject to civil penalties of up to \$2,000 or twice the amount of the prohibited contributions made by their principals.

<u>Criminal penalties</u>—Any knowing and willful violation of the prohibition is a Class D felony, which may subject the violator to imprisonment of not more than 5 years, or not more than \$5,000 in fines, or both.

CONTRACT CONSEQUENCES

In the case of a state contractor, contributions made or solicited in violation of the above prohibitions may result in the contract being voided.

In the case of a prospective state contractor, contributions made or solicited in violation of the above prohibitions shall result in the contract described in the state contract solicitation not being awarded to the prospective state contractor, unless the State Elections Enforcement Commission determines that mitigating circumstances exist concerning such violation.

The State shall not award any other state contract to anyone found in violation of the above prohibitions for a period of one year after the election for which such contribution is made or solicited, unless the State Elections Enforcement Commission determines that mitigating circumstances exist concerning such violation.

DEFINITIONS

"State contractor" means a person, business entity or nonprofit organization that enters into a state contract. Such person, business entity or nonprofit organization shall be deemed to be a state contractor until December thirty-first of the year in which such contract terminates. "State contractor" does not include a municipality or any other political subdivision of the state, including any entities or associations duly created by the municipality or political subdivision exclusively amongst themselves to further any purpose authorized by statute or charter, or an employee in the executive or legislative branch of state government or a quasi-public agency, whether in the classified or unclassified service and full or part-time, and only in such person's capacity as a state or quasi-public agency employee.

"Prospective state contractor" means a person, business entity or nonprofit organization that (i) submits a response to a state contract solicitation by the state, a state agency or a quasi-public agency, or a proposal in response to a request for proposals by the state, a state agency or a quasi-public agency, until the contract has been entered into, or (ii) holds a valid prequalification certificate issued by the Commissioner of Administrative Services under section 4a-100. "Prospective state contractor" does not include a municipality or any other political subdivision of the state, including any entities or associations duly created by the municipality or political subdivision exclusively amongst themselves to further any purpose authorized by statute or charter, or an employee in the executive or legislative branch of state government or a quasi-public agency, whether in the classified or unclassified service and full or part-time, and only in such person's capacity as a state or quasi-public agency employee.

"Principal of a state contractor or prospective state contractor" means (i) any individual who is a member of the board of directors of, or has an ownership interest of five per cent or more in, a state contractor or prospective state contractor, which is a business entity event for an individual who is a member of the board of directors of a nonprofit organization, (ii) an individual who is employed by a state contractor or prospective state contractor, which is a business entity, as president, treasurer or executive vice president, (iii) an individual who is the chief executive officer of a state contractor or prospective state contractor, which is not a business entity, or if a state contractor or prospective state contractor or prospective state comparable powers and duties, (iv) an officer or an employee of any state contractor or prospective state contractor who has managerial or discretionary responsibilities with respect to a state contract, (v) the spouse or a dependent child who is eighted years of age or older of an individual described in this subparagraph, or (vi) a political committee established or controlled by an individual described in this subparagraph or the business entity or nonprofit organization that is the state contractor or prospective state contractor.

"State contract" means an agreement or contract with the state or any state agency of any quasi-public agency, let through a procurement process or otherwise, having a value of fifty thousand dollars or more, or a combination of series of such agreements or contracts having a value of one hundred thousand dollars or more in a calendar year, for (i) the rendition of services, (ii) the furnishing of any goods, material, supplies, equipment or any items of any kind, (iii) the construction, alteration or repair of any public building of subtic work, (iv) the acquisition, sale or lease of any land or building, (v) a licensing arrangement, or (vi) a grant, loan or loan guarantee. "State contract," those not include any agreement or contract with the state, any state agency or any quasi-public agency that is exclusively federally funded, an education can, a loan to an individual for other than commercial purposes or any agreement or contract between the state or any state agency and the United States popartment of the Navy or the United States Department of Defense.

"State contract solicitation" means a request by a state agency or masi-public agency, in whatever form issued, including, but not limited to, an invitation to bid, request for proposals, request for information or request enquotes, inviting bids, quotes or other types of submittals, through a competitive procurement process or another process authorized by law waiving compatible procurement.

"Managerial or discretionary responsibilities with respect to a state contract" means having direct, extensive and substantive responsibilities with respect to the negotiation of the state contract and not periphered clerical or ministerial responsibilities.

"Dependent child" means a child residing in an individual's household who may legally be claimed as a dependent on the federal income tax return of such individual.

"Solicit" means (A) requesting that a contribution be made, (B) participating in any fundraising activities for a candidate committee, exploratory committee, political committee or party committee, including, but not limited to, forwarding tickets to potential contributors, receiving contributions for transmission to any such committee, serving on the committee that is hosting a fundraising event, introducing the candidate or making other public remarks at a fundraising event, being honored or otherwise recognized at a fundraising event, or bundling contributions, (C) serving as chairperson, treasurer or deputy treasurer of any such committee, or (D) establishing a political committee for the sole purpose of soliciting or receiving contributions for any committee. "Solicit" does not include (i) making a contribution that is otherwise permitted under this chapter, (ii) informing any person of a position taken by a candidate for public office or a public official, (iii) notifying the person of any activities of, or contact information for, any candidate for public office, (iv) serving as a member in any party committee or as an officer of such committee that is not otherwise prohibited in this subdivision, or (v) mere attendance at a fundraiser.

"Subcontractor" means any person, business entity or nonprofit organization that contracts to perform part or all of the obligations of a state contractor's state contract. Such person, business entity or nonprofit organization shall be deemed to be a subcontractor until December thirty-first of the year in which the subcontract terminates. "Subcontractor" does not include (i) a municipality or any other political subdivision of the state, including any entities or associations duly created by the municipality or political subdivision exclusively amongst themselves to further any purpose authorized by statute or charter, or (ii) an employee in the executive or legislative branch of state government or a quasi-public agency, whether in the classified or unclassified service and full or part-time, and only in such person's capacity as a state or quasi-public agency employee.

"Principal of a subcontractor" means (i) any individual who is a member of the board of directors of, or has an ownership interest of five per cent or more in, a subcontractor, which is a business entity, except for an individual who is a member of the board of directors of a nonprofit organization, (ii) an individual who is employed by a subcontractor, which is a business entity, as president, treasurer or executive vice president, (iii) an individual who is the chief executive officer of a subcontractor, which is not a business entity, or if a subcontractor has no such officer, then the officer who duly possesses comparable powers and duties, (iv) an officer or an employee of any subcontractor who has managerial or discretionary responsibilities with respect to a subcontract with a state contractor, (v) the spouse or a dependent child who is eighteen years of age or older of an individual described in this subparagraph, or (vi) a political committee established or controlled by an individual described in this subparagraph or the business entity or nonprofit organization that is the subcontractor.

CONNECTICUT HOUSING FINANCE AUTHORITY ETHICS STATEMENT

The Connecticut Housing Finance Authority ("CHFA") was created in 1969 by the State legislature as a quasi-public agency of the State of Connecticut. Its purpose is to help alleviate the shortage of affordable housing for low and moderate-income families and persons in Connecticut, and when appropriate, to promote or maintain the economic development of the State through employer-assisted housing efforts.

CHFA administers a multi-billion dollar portfolio of housing related financing in the State resulting primarily from its loan programs for both single and multifamily housing. These programs are financed by the proceeds of tax exempt and taxable bonds issued by CHFA together with State funds it administers and its own funds. CHFA has significant interaction with the State and private financial markets and has relationships with both nonprofit and for profit developers of housing. It is important that the CHFA Board of Directors and its employees and persons doing business or seeking to do business with CHFA understand and comply at all times with CHFA's ethical standards in the performance of their duties and conduct of their business.

It is the policy of the Connecticut Housing Finance Authority that its employces and members of its Board of Directors will comply with all laws and regulations pertaining to the conduct of CHFA's business and administration of its programs and that they will do so with the highest standards of ethical behavior. Those with whom CHFA does business are expected to similarly comply with applicable laws and regulations and standards. Any breach or deviation from applicable laws and regulations or standards will result in appropriate disciplinary action including but not limited to termination of employment and sanctions as required by CHFA and state law.

The CHFA Board of Directors and all CHFA employees are subject to the Code of Ethics for Public Officials, Connecticut General Statutes Chapter 10, Part 1, §§1-79 through 1-89 as amended ("Code of Ethics") in the discharge of their duties, including, but not limited to, the following provisions:

- Gifts In general, acceptance of gifts from anyone doing business with or seeking to do business with CHFA of from persons known to be a registered lobbyist or lobbyist's representative is prohibited
- Financial Benefit use of office for financial benefit of the individual, certain family members or associate nesses is prohibited
- Outside Employment outside employment which may impair independence of judgment or induct diplosure of confidential information is prohibited (Note: Connecticut General Statutes § 8-244(b) provides notwithstanding the provision of any other law to the contrary, it shall not constitute a conflict of interest for a trustee, director, partner or officer of any person, firm or conportation, or any individual having a financial interest in a person, firm or corporation, to serve as a member of the authority, provided such discee, director, partner, officer or individual shall abstain from deliberation, action or vote by the authority in specific respect to such person, firm or corporation.)
- Financial Disclosure filing of financial disclosure statements with the State Ethics Contristion is required by certain employees and the Board of Directors
- Post -State Employment accepting employment with parties to contracts or regular parties upon leaving CHFA is restricted (Note: Connecticut General Statutes § 1-84b(c) provides exceptions for members or former members of the boards or commissions who serve ex officio, who are required by statute to represent the regulated industry or who are permitted wstatute to have a past or present affiliation with the regulated industry.)





If, after the hearing, the human rights referee finds a violation, the referee may award the aggrieved employee reinstatement of the employee's former position, back pay and reestablishment of any employee benefits for which the employee would otherwise have been eligible if such violation had not occurred, reasonable attorneys' fees and any other damages. For the purposes of this subsection, such human rights referee shall act as an independent hearing officer. The decision of a human rights referee under this subsection may be appealed by any person who was a party at such hearing, in accordance with the provisions of section 4-183.

(B) The Chief Human Rights Referee shall adopt regulations, in accordance with the provisions of chapter 54, establishing the procedure for filing complaints and noticing and conducting hearings under subparagraph (A) of this subdivision.

(3) As an alternative to the provisions of subdivision (2) of this subsection, an employee of a state shellfish grounds lessee who alleges that a personnel action has been threatened or taken may, after exhausting all available administrative remedies, bring a civil action in accordance with the provisions of subsection (c) of section 31-51m.

(4) In any proceeding under subdivision (2) or (3) of this subsection concerning a personnel action taken or threatened against any employee of a state shellfish grounds lessee, which personnel action occurs not later than two years after the employee first transmits facts and information to an employee of the leasing agency concerning the state shellfish grounds
