REQUEST FOR PROPOSAL ("RFP") FOR SINGLE FAMILY REAL ESTATE BROKERAGE SERVICES

Date: November 20, 2020

The Connecticut Housing Finance Authority ("<u>CHFA</u>") requests proposals for single family real estate brokerage services from licensed and qualified real estate brokerage firms with offices in the State of Connecticut. CHFA will not reimburse for any expenses incurred in connection with this RFP including, but not limited to, the cost of preparing the initial response and any additional information requested or travel expenses relating to an oral presentation. Please be advised that responses will be considered property of CHFA, are matters of public record and may be disclosed by CHFA after the awarding of the contract.

OVERVIEW

CHFA, a body politic and corporate constituting a public instrumentality and political subdivision of the State of Connecticut, was created in 1969 and operates pursuant to Chapter 134 of the Connecticut General Statutes, as amended. CHFA's purpose is to help alleviate the shortage of affordable housing for low- and moderate-income families and persons in Connecticut by providing single family mortgages, financing for rental housing, and mortgages for the purchase, development and construction of housing.

SCOPE OF SERVICES

CHFA is seeking the services of licensed and qualified real estate brokerage firms to list, for sale, real estate owned single family properties acquired by CHFA through the State of Connecticut judicial foreclosure process (each an "REO"). The selected brokers must be participants of the Multiple Listing Services (MLS). Selected brokers will receive individual listing assignments under a master listing agreement with the selected broker's firm. Listing assignments will be issued by CHFA, at its sole discretion. Brokers will be required to provide a broker opinion of value along with a marketing plan within seven (7) days of receiving a new listing assignment. Each listing engagement will be for a period of three (3) months. Each selected real estate broker will be expected to execute a three-year contract with CHFA in substantially the form of the attached **Exhibit A**. All selected brokers will be required to sign an Exclusive Right to Sell/Listing Agreement in substantially the form of **Exhibit B** and, **Schedule 1** for each individual property listed. All responses must be submitted on the attached form provided by CHFA.

EVALUATION CRITERIA

Firms will be evaluated on the basis of their written response to this RFP, additional written information as requested by CHFA and oral interviews, if any, including, but not limited to the following criteria:

- REO sale experience of the firm
- Qualifications of personnel
- Organization and approach

- Fees
- Equal employment opportunity and affirmative action
- Connecticut presence
- Conflicts or potential conflicts
- Location/geographic area

CHFA may select multiple firms for the services described herein. No selected firm is guaranteed or ensured any number of contracts or proportion of business.

REQUESTED INFORMATION

All firms must address the following issues and questions:

- 1. Provide a brief description of your firm, its history and main areas of business. Indicate the total number of staff and the team available to CHFA.
- 2. Provide a summary of the key strengths and qualifications of your firm to sell REO and occasionally distressed properties. (Your response to this question should not exceed one page)
- 3. Describe your presence in Connecticut, if any, including corporate existence in Connecticut, whether formed in Connecticut or authorized to do business in the state. This may include, but not be limited to, information on the number of offices your firm maintains in Connecticut, the location of such offices, the number of Connecticut residents employed in those offices, and payroll and corporate taxes paid in Connecticut. If your firm currently is not registered with the Connecticut Secretary of State, please indicate whether your firm will so register if your firm is awarded this contract.
- 4. Include any participation by your firm in any civic or other non-profit activities, including any charitable contributions that your firm has made in the State of Connecticut.
- 5. Provide a brief summary of the professional background of any individuals who would be assigned to work with CHFA. Please indicate their probable areas of responsibility and the percentage of their time which would be available to service CHFA's account.
- 6. Describe what type of marketing CHFA can expect on its properties listed with your firm to maximize market awareness (e.g., frequency of open houses, print and/or electronic media, etc.).
- 7. Provide in tabular form, information on the employee composition of your firm indicating the total number of employees and the total number and percentages of minorities and women employed and their titles.
- 8. Submit specific information regarding your company's commitment to Affirmative Action. Please include at a minimum formal internal hiring practices and discussion of working relationships with women and minority-owned companies. Please include your company's most recent Equal Employment Opportunity Commission report, if required to file.

- 9. Provide current documentation regarding your firm's general liability, automobile, workers' compensation, umbrella liability insurance and professional liability insurance in the amounts that are listed on the attached **Exhibit C**.
- 10. Provide a copy of your Connecticut Real Estate Broker License.
- 11. Describe any and all material lawsuits, legal or administrative proceedings or governmental investigations, criminal actions or law enforcement activities (including those by federal, state or local authorities, or self-regulatory organizations) or non-routine inquiries or investigations relating to you, your firm, or any of your affiliates, including any proceedings to which you, your firm, your affiliates or any of their respective officers, directors or employees are a named party or of which any of such has been the focus, that have occurred in the last three (3) years or that are currently threatened, including whether you, your firm, or any of your affiliates, or their respective officers, directors or employees have been censured by any regulatory body. Describe any such circumstances and advise whether these investigations or proceedings will affect you or your firm's ability to complete the proposed transaction and perform the services in this RFP.
- 12. Describe whether you foresee any potential conflicts of interest arising from providing real estate brokerage services for CHFA.
- 13. Has your firm ever been removed from an account prior to the expiration of its contract (i.e. been fired)? If so, please explain. If you wish, list the name of a third party with whom CHFA could discuss this termination.
- 14. Describe your firm's knowledge of and past experience with CHFA.
- 15. Please provide as references, a minimum of three clients for whom your firm has performed similar and substantial services. Please include the name of the person to contact and his or her phone number. Please include as references any other State of Connecticut agencies or departments that have engaged your firm to provide services.
- 16. Selected firms must comply with CHFA and State Ethics requirements, laws and regulations. Persons seeking to do business with CHFA are required to comply with the attached ethics statement and the applicable provisions of the Code of Ethics and Code of Ethics for Lobbyists incorporated therein by reference. An authorized signatory of the bidder or vendor shall execute and submit with the proposal the attached certifications regarding Connecticut General Statutes sections 4-250 and 4-252a, which are attached as **Exhibit D**. In addition, the authorized signatory of the firm awarded this contract shall execute a master listing agreement, the CHFA statutory provisions, affidavits and certifications, which are attached for informational purposes as **Exhibit E**.
- 17. Describe your proposed Real Estate Brokerage Services fee structure, including the compensation of co-brokers when applicable.

SUBMISSION OF RESPONSES

The following requirements must be observed in the preparation and submission of a proposal:

- 1. All inquiries should be directed to Shelly Mondo at RFP.RFQ@chfa.org no later than Tuesday, December 1, 2020. Firms submitting a proposal should not contact members of the Board of Directors or other staff of CHFA, which may be grounds for elimination from consideration.
- 2. The entire proposal must not exceed 20 single-sided pages.
- 3. Submissions can be sent electronically (not to exceed 25 MB) to RFP.RFQ@chfa.org OR one original copy delivered to CHFA, 999 West Street, Rocky Hill, CT 06067 ATTN: Shelly Mondo, no later than 12:00 p.m. on Monday, December 21, 2020. Faxed responses will not be considered.
- Responses must include a cover letter signed by an individual authorized to enter into an agreement with CHFA on behalf of the firm which shall specify the category for which the proposal is being submitted.
- 5. Selected firms must comply with all state and federal laws applicable to CHFA including, but not limited to, ethics requirements, laws, procedures and regulations and must execute (with the master listing agreement) CHFA statutory provisions, certifications and affidavits attached hereto as **Exhibit E**.

CHFA reserves the right to:

- a. Reject any and all proposals received in response to this request;
- b. Negotiate the fees contained in any proposal;
- c. Waive or modify any irregularities in proposals received;
- d. Award contracts in any manner necessary to serve the best interest of CHFA and the State
 of Connecticut, without obligation to accept a proposal based upon the lowest fee schedule;

- e. Request additional information as determined necessary or request some or all firms responding to make oral presentations.

Each approved firm will execute a contract satisfactory to CHFA and will agree that it will comply with the provisions of Connecticut General Statutes applicable to contracts with CHFA including, but not limited to, nondiscrimination and affirmative action provisions. Failure to comply with the requirements of this RFP may result in CHFA's rejection of a proposal.

Exhibit A

AGREEMENT

This Agreement is made and entered into as of this day of 2020, by and between the Connecticut Housing Finance Authority ("CHFA"), a body politic and corporate constituting a public instrumentality and political subdivision of the State of Connecticut and having its office at 999 West Street, Rocky Hill, Connecticut 06067 and, a, having its principal place of business at, ("Contractor").
In consideration of the mutual covenants, promises and representations contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CHFA and Contractor hereby agree as follows:
ARTICLE 1 - Scope of Services.
Contractor shall for CHFA real estate brokerage services for single-family properties acquired by CHFA through foreclosures (the "Services"). For each single-family property listed for sale, the Contractor shall enter into an Exclusive Right to Sell/Listing Agreement in substantially the form of the attached Schedule 1.
ARTICLE 2 - Compensation.
A. CHFA will pay Contractor in accordance with the fee sheet set forth in Schedule 1 (Exclusive Right to Sell/Listing Agreement) attached hereto.
B. Contractor shall submit all requests for payment in writing, and CHFA will pay Contractor within 30 days of receipt of an invoice.
ARTICLE 3 - Term.
The term of this Agreement shall commence on and continue for up to () years and/or until Contractor's successor is designated as determined by CHFA unless:
(i) the parties mutually agree in writing to an extension thereof; or (ii) this Agreement is terminated in
accordance with the terms and provisions hereof.
ARTICLE 4 - Reports.
Any reports and studies prepared by Contractor under this Agreement shall be the property of CHFA and shall be delivered to CHFA upon request.

ARTICLE 5 - Termination.

CHFA may terminate this Agreement upon 30 days written notice, provided, however, that CHFA may terminate this Agreement at any time for non performance as determined by CHFA.

In addition, CHFA shall have the right to terminate this Agreement in whole or in part without penalty in the event sufficient funds to provide for CHFA's payments under this Agreement are not appropriated, not authorized or not made available pursuant to law, or such funding has been reduced pursuant to law.

ARTICLE 6 - Warranties and Representations.

Connecticut and maintains all licenses, permits and approvals required for the operation of his business and performance of the Services. Contractor warrants and represents it is in compliance with statutory provisions described in Exhibit attached hereto and made a part hereof and will remain in compliance during the term of this Agreement.

ARTICLE 7 - Assignment and Subcontracting.

This Agreement shall not be assigned or pledged nor shall the duties therein be subcontracted for by Contractor.

ARTICLE 8 - Applicable Law.

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Connecticut.

ARTICLE 9 - Notices.

All notices, requests, demands and other communications hereunder shall be deemed to have been duly given if delivered or mailed via certified first class mail return receipt requested postage prepaid, or overnight express mail service to the addresses on page 1 hereof.

ARTICLE 10 - Entire Agreement.

This Agreement constitutes the entire Agreement between the parties hereto and concerning the subject matter hereof and supersedes any previous agreements, written or oral, between the parties hereto and concerning the subject matter hereof. This Agreement may be modified only by a writing signed by the parties hereto that specifically refers to this Agreement.

ARTICLE 11 - Benefit and Burden.

This Agreement shall not inure to the benefit of and shall not be binding upon the heirs, personal representatives, successors and assigns of the parties hereto. The provisions of this Agreement are solely for the benefit of the parties hereto and not for the benefit of any other person or entity.

ARTICLE 12 - Severability.

If any part, term or provision of this Agreement is held by any court to be invalid, illegal or in conflict with any applicable law, the validity of the remaining portions of this Agreement shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if this Agreement

did not contain the particular part, term or provision held to be invalid, illegal or in conflict with any applicable law.

ARTICLE 13 - No Waiver.

Failure to enforce any provision of this Agreement or to require at any time performance of any provision hereof shall not be construed to be a waiver of such provision, or to affect the validity of this Agreement or the right of any party to enforce each and every provision in accordance with the terms hereof.

ARTICLE 14 - Usage.

Whenever nouns or pronouns are used in this Agreement, the singular shall mean the plural, the plural shall mean the singular and the use of any gender shall mean all genders or any other gender, as the context may require.

ARTICLE 15 - Captions.

The captions contained in this Agreement have been inserted for convenience only and shall not affect or be effective to interpret, change or restrict the terms or provisions of this Agreement.

ARTICLE 16 - Status of Contractor.

Contractor acknowledges and agrees that Contractor is acting as an independent contractor in performing Services for CHFA hereunder and that Contractor shall perform such Services in its own manner and method subject to the terms of this Agreement. Nothing in this Agreement shall be construed or interpreted as creating a partnership, a joint venture, an agency, a master-servant relationship or any employer-employee relationship between CHFA and Contractor. Contractor is expressly forbidden from transacting any business in the name of or on account of CHFA, and Contractor has no power or authority to assume or create any obligation or responsibility for or on behalf of CHFA in any manner whatsoever.

ARTICLE 17 - Time is of the Essence.

Time is of the essence.

ARTICLE 18 – Indemnity.

Contractor agrees (which agreement shall survive the expiration or termination of this Agreement) to defend, indemnify and hold CHFA, its agents, employees and Board of Directors harmless from and against any and all loss, liability, damage, costs, causes of action, claims and expenses, including litigation expenses and attorney's fees (individually and collectively, "Claims") for injury (including death to persons and physical damage to property) resulting from the acts or omissions of the Contractor, its consultants, agents, subcontractors or employees. Contractor also agrees (which agreement shall survive the expiration or termination of this Agreement) to defend, indemnify and hold CHFA, its agents, employees and Board of Directors harmless from and against any and all Claims arising out of a breach of any of the agreements set forth in this Agreement by Contractor in connection with the Services.

ARTICLE 19 - Miscellaneous.

- A. Contractor shall not issue or sponsor any advertising or publicity that states or implies that CHFA prefers or recommends its services.
- B. Contractor shall notify CHFA immediately whenever work under this Agreement conflicts with or appears to conflict with Contractor's obligation(s) to another person or organization and shall provide sufficient details for CHFA's evaluation. Contractor shall not proceed with performance of the Services until written notification to do so is given by CHFA.
- C. Contractor must provide list of references, current insurance certificates endorsing CHFA as an additional insured in amounts satisfactory to CHFA and any applicable licenses.

- 2. CHFA hereby grants to Broker the exclusive right to secure offers from prospective buyers for the purchase of certain real property (each individual), and collectively, the "Property"). Each individual Property shall be identified from time to time during the term of this Agreement in the format set forth on Schedule 1, attached hereto and made a part hereof. Each such Schedule shall set forth the specific terms and conditions upon which the listing of said individual Property shall be conducted by Broker, which terms and conditions shall be in addition to the general terms and conditions set forth in this Agreement and otherwise applicable to the listing.
- 3. In consideration of the services to be performed by Broker hereunder, CHFA hereby agrees to pay a sales commission (the "Commission") equal to: (A) in the event that Broker represents only CHFA and not the purchaser, the greater of: (i) Three Thousand and No/100 Dollars (\$3,000); or (ii) six percent (6%) of an amount equal to: (a) the Purchase Price, less (b) any CHFA contribution or credit toward closing costs and/or other pre-paid amounts, as identified in the purchase contract and or, the closing settlement statement; or (B) in the event of dual agency by virtue of which Broker represents both CHFA and the purchaser, the greater of: (i) Two Thousand Five Hundred and No/100 Dollars (\$2,500); or (ii) five percent (5%) of an amount equal to: (1) the Purchase Price; less (2) any CHFA contribution or credit toward closing costs and/or other pre-paid amounts, as identified in the purchase contract or on the closing settlement statement.

The Commission shall be earned by Broker only upon a successful closing with a buyer who purchases the Property upon the authorized terms and conditions hereunder and as accepted by CHFA in its sole discretion. Payment of the Commission shall be made no earlier than the date of the transfer of the conveyance deed for the Property.

CHFA agrees that Broker may share the Commission with a broker acting as buyer's agent and payment of a fee to buyer's agent shall not create any agency or sub-agency relationship between buyer's agent and CHFA. Broker may not appoint subagents other than those affiliated with Broker's firm as independent contractors or employees without CHFA's consent. THE BROKER MAY BE ENTITLED TO CERTAIN LIEN RIGHTS PURSUANT TO SUBSECTION (d) OF SECTION 20-325A OF THE CONNECTICUT GENERAL STATUTES. Broker is authorized to accept and hold in an escrow account on CHFA's behalf, a deposit to be applied toward the purchase price. Broker shall comply with all applicable laws regarding such deposits. CHFA understands that Broker may represent buyers. In the event that Broker becomes agent for a prospective buyer of the Property, Broker will become a dual agent and Broker will notify CHFA immediately and seek CHFA's informed written consent to act as dual agent, which consent may be provided by electronic means.

- 4. CHFA agrees to provide Broker with complete and accurate information concerning the Property, all to the best of CHFA's knowledge, and to complete a "Seller Property Condition Disclosure Report", as required by law, and to update said disclosure report if there are any changes during the term of this Agreement. Broker shall provide said property disclosure report to any buyer prior to the execution of a written offer to purchase the Property. CHFA of each est that Broker may provide data describing the Property and the disclosure report to other largers, agents, prospective buyers. Broker shall not disclose confidential information about the price or terms that might be acceptable to CHFA or information about CHFA's motivation for selling the Property.
- 5. CHFA acknowledges it has received and read the "Notice to Sellers About Environmental Hazards." CHFA is responsible to provide the Broker with all relevant information about environmental issues that affect the Property, all to me best of CHFA's knowledge. In the event that the Property consists of or contains, a residential unit built prior to 1978, CHFA agrees to provide Broker and any actual buyers with a completed "Disclosure and Acknowledgement Form Re: Lead Based Paint" containing all information known to CHFA, all to the best of CHFA's knowledge, concerning the presence of lead-based paint hazards on the Property, including any test reports. FEDERAL LAW REQUIRES THE OWNER OF A DWELLING TO DISCLOSE THE PRESENCE OF LEAD-BASED PAINT AND LEAD-BASED PAINT HAZARDS TO PURCHASERS AND TO FURNISH PURCHASERS WITH ANY RECORDS OR REPORTS CONCERNING LEAD-BASED PAINT OR LEAD-BASED PAINT HAZARDS. understands that because of the potential serious health risks associated with lead substances, asbestos, radon, urea for and chyde foam insulation ("UFFI") and other environmentally hazardous conditions, prospective buyers should be advised if these conditions are present or have existed in the Property. CHFA understands that failure to make such a material disclosure could be a violation of federal and/or Connecticut law and could result in (i) the rescission of any purchase agreement between CHFA and a prospective buyer, and/or (ii) an award of damages against CHFA, as the seller, or any person responsible for disclosing the information regarding the Property. CHFA specifically directs and authorizes Broker, as CHFA's agent, to disclose any such existing conditions to prospective buyers. If any possible hazardous material has been tested for, or treated and remedied, CHFA agrees to notify Broker in writing the details of the remediation and results and copies of any tests, all to the best of CHFA's knowledge.

- 6. Broker shall use reasonable and diligent efforts to sell the Property. CHFA shall refer all inquiries and offers that it receives concerning the Property to Broker. Broker is authorized to advertise the Property as Broker deems appropriate, including, without limitation, utilizing print or electronic media. Broker may place a customary "For Sale" sign and/or lockbox on the Property and, when all contingencies have been satisfied and CHFA has so authorized, Broker may place a "SOLD" sign on the Property. Broker agrees to submit the Property to the multiple listing service where Broker holds primary membership ("MLS"). CHFA understands that information about the Property will be disseminated to participants of the MLS in accordance with its rules and regulations and Broker is authorized by CHFA to cooperate with other real estate brokers, whether members of the MLS or not. CHFA understands that other authorized participants in MLS will have access to this lockbox, subject to the applicable MLS lockbox rules and regulations. Broker shall not be responsible for the maintenance, management or upkeep of the Property.
- 7. The Agreement is subject to Connecticut General Statutes prohibiting discrimination in commercial and residential real estate transactions including, without limitation, Connecticut General Statutes, Title 46a, Chapter 814c, as amended. IT IS UNLAWFUL UNDER FEDERAL AND/OR STATE LAW TO DISCRIMINATE ON THE BASIS OF RACE, RELIGION, CREED, COLOR, NATIONAL ORIGIN, ANCESTICY, SEX, MARITAL STATUS, AGE, LAWFUL SOURCE OF INCOME, MENTAL RETARDATION, LEARNING DISABILITY, MENTAL DISABILITY OR PHYSICAL DISABILITY, SEXUAL ORIENTATION AND FAMILIAL STATUS IN ACQUIRING OR DISPOSITION OF REAL PROPERTY.
- 8. Broker warrants and represents that Broker's authorized to do business in the state of Connecticut and maintains all licenses, permits and approvals required for the operation of Broker's business and Broker's performance hereunder. Broker warrants and represents that Broker is in compliance with any and all applicable laws and shall remain in compliance during the term of this Agreement.
- 9. This Agreement constitutes he entire listing agreement for the Property between the parties and any prior agreements, whether oral or written have been merged and integrated into this Agreement. No modification of any of the terms of this Agreement shall be valid, binding or enforceable upon the parties unless in writing and signed by both parties. This Agreement shall be governed by and interpreted in accordance with the laws of the State of Connecticut. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute but one and the same Agreement. Signatures provided by electronic means shall be deemed binding on the parties. Time is of the essence in performance hereunder.

All contractors and vendors are required to provide proof of the required insurance coverage before entering the premises or commencing any work at any CHFA facility. Contractors and vendors must obtain, at their own expense, all the insurance required here, and acceptable evidence of such insurance must be properly furnished to, and approved by, CHFA.

All subcontractors are subject to the same requirements. It is the responsibility of the primary contractor or vendor to obtain acceptable evidence of insurance from subcontractors.

CHFA also requires that they be named as an additional insured on your general liability policy(ies). Your general liability policy must be endorsed with ISO Endorsement CG 20 10 (or equivalent) or ISO Endorsement CG 20 26 (or equivalent), and ISO Endorsement CG 20 37 (or equivalent) if so required. These form numbers must be specifically referenced on the certificate of insurance. If your insurance company uses a different form to provide CHFA with additional insured status on your policies, copies of those forms must be provided in advance with the insurance certificate for review and approval by CHFA. All coverage must be primary as to CHFA.

Insurance Requirements for Contractors or Vendors

Insurance Requirements

Contractors or vendors working for and/or doing business with the Connecticut Housing Finance Authority (CHFA), or using CHFA facilities, shall agree as a condition of acceptance to furnish and perpetually maintain, at their own expense, for the duration of any project, work, contract or use of CHFA facilities the following policies of insurance covering the following items. Insurance must be primary and endorsed to be noncontributory by CHFA, must be written in an insurance company A.M. Best rated as "A-VII" or better, and CHFA must be endorsed to the policy as an additional insured (except Worker's Compensation) unless this requirement is specifically waived in writing by CHFA. Contractors further agree that any subcontractor they intend to use on CHFA assigned work will be required to submit to the same indemnity and insurance requirements contained in this schedule. Contractor shall obtain insurance certificates stating that both Contractor and CHFA shall be endorsed to the subcontractor's insurance policies as additional insured.

Indemnification

The contractor/vendor shall save harmless, indemnify, and in the event of claim, notification or suit will immediately defend CHFA and any related or subsidiary entities, their officers, employees and volunteers, from and against all loss, costs, damage, expense, claims or demands arising out of or caused or alleged to have been caused in any manner by the performance of work or use of facilities herein provided, including all suits, claims or actions of every kind or description brought against the CHFA either individually or jointly with the entity or organization for or on the account of any damage or injury to any person or persons or property, including the entity or organization's employees or their property, caused or occasioned, or alleged to have been caused or occasioned in whole or in part by the entity or organization, including any subcontractor, their employees or agents.

Certificates of Insurance

Before starting any work, or commencing any use or occupancy of CHFA premises, the contractor or vendor shall furnish to CHFA a certificate of insurance indicating, specifically, the existence of those coverages and limits set forth as follows. CHFA must be named on the insurance certificate as "additional insured" for the coverage's afforded, and a copy of the actual policy endorsement that adds CHFA as an additional insured must be attached to the certificate (Blanket additional insured endorsements are deemed acceptable). It is also the duty of contractor or vendor to provide renewal or replacement certificates and endorsements to CHFA upon renewal or new placement of any insurance policy which may expire or renew during the term of any project or engagement, and to give CHFA thirty (30) days notice of any cancellation or change in the terms of such policy or policies during the periods of coverage. Upon request of CHFA, the contractor or vendor shall furnish to CHFA for its examination and approval such policies of insurance with all endorsements, or copies thereof, certified by the agent of the insurance company.

Acknowledgement of Receipt of Explanation of Prohibitions for Incorporation in Contracting and Bidding Documents

This notice is provided under the authority of Connecticut General Statutes § 9-612 (f) (2) and is for the purpose of informing state contractors and prospective state contractors of the following law (italicized words are defined on the reverse side of this page).

CAMPAIGN CONTRIBUTION AND SOLICITATION LIMITATIONS

No state contractor, prospective state contractor, principal of a state contractor or principal of a prospective state contractor, with regard to a state contract or state contract solicitation with or from a state agency in the executive branch or a quasi-public agency or a holder, or principal of a holder, of a valid prequalification certificate, shall make a contribution to (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of Governor, Lieutenant Governor, Attorney General, State Comptroller, Secretary of the State or State Treasurer, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee (which includes town committees).

In addition, no holder or principal of a holder of a valid prequalification certificate shall make contribution to (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of state senator or state representative, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee.

On and after January 1, 2011, no state contractor, prospective state contractor, practipal of a state contractor or principal of a prospective state contractor, with regard to a state contract or state contract solicitation with or from a state agency in the executive branch or a quasipublic agency or a holder, or principal of a holder of a valid prequalification or difficate, shall **knowingly** solicit contributions from the state contractor's or prospective state contractor's employees or from a subcontractor or principals of the subcontractor on behalf of (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of Governor, Lieutenant Governor, Attorney General, State Comptroller, Secretary of the State or State Treasurer, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee.

DÚTÝ TO INFORM

State contractors and prospective state contractors are uired to inform their principals of the above prohibitions, as applicable, and the possible penalties and other consequences of any violation thereof.

PENALTIES FOR VIOLATIONS

Contributions or solicitations of contributions made in violation of the above prohibitions may result in the following civil and criminal penalties:

<u>Civil penalties</u>—Up to \$2,000 or twice the amount of the prohibited contribution, whichever is greater, against a principal or a contractor. Any state contractor or prospective state contractor which fails to make reasonable efforts to comply with the provisions requiring notice to its principals of these prohibitions and the possible consequences of their violations may also be subject to civil penalties of up to \$2,000 or twice the amount of the prohibited contributions made by their principals.

<u>Criminal penalties</u>—Any knowing and willful violation of the prohibition is a Class D felony, which may subject the violator to imprisonment of not more than 5 years, or not more than \$5,000 in fines, or both.

CONTRACT CONSEQUENCES

In the case of a state contractor, contributions made or solicited in violation of the above prohibitions may result in the contract being voided.

In the case of a prospective state contractor, contributions made or solicited in violation of the above prohibitions shall result in the contract described in the state contract solicitation not being awarded to the prospective state contractor, unless the State Elections Enforcement Commission determines that mitigating circumstances exist concerning such violation.

The State shall not award any other state contract to anyone found in violation of the above prohibitions for a period of one year after the election for which such contribution is made or solicited, unless the State Elections Enforcement Commission determines that mitigating circumstances exist concerning such violation.

DEFINITIONS

"State contractor" means a person, business entity or nonprofit organization that enters into a state contract. Such person, business entity or nonprofit organization shall be deemed to be a state contractor until December thirty-first of the year in which such contract terminates. "State contractor" does not include a municipality or any other political subdivision of the state, including any entities or associations duly created by the municipality or political subdivision exclusively amongst themselves to further any purpose authorized by statute or charter, or an employee in the executive or legislative branch of state government or a quasi-public agency, whether in the classified or unclassified service and full or part-time, and only in such person's capacity as a state or quasi-public agency employee.

"Prospective state contractor" means a person, business entity or nonprofit organization that (i) submits a response to a state contract solicitation by the state, a state agency or a quasi-public agency, or a proposal in response to a request for proposals by the state, a state agency or a quasi-public agency, until the contract has been entered into, or (ii) holds a valid prequalification certificate issued by the Commissioner of Administrative Services under section 4a-100. "Prospective state contractor" does not include a municipality or any other political subdivision of the state, including any entities or associations duly created by the municipality or political subdivision exclusively amongst themselves to further any purpose authorized by statute or charter, or an employee in the executive or legislative branch of state government or a quasi-public agency, whether in the classified or unclassified service and full or part-time, and only in such person's capacity as a state or quasi-public agency employee.

"Principal of a state contractor or prospective state contractor" means (i) any individual who is a member of the board of directors of, or has an ownership interest of five per cent or more in, a state contractor or prospective state contractor, which is a business entity except for an individual who is a member of the board of directors of a nonprofit organization, (ii) an individual who is employed by a state contractor or prospective state contractor, which is a business entity, as president, treasurer or executive vice president, (iii) an individual who is the chief executive officer of a state contractor or prospective state contractor, which is not a business entity, or if a state contractor or prospective state contractor has be such officer, then the officer who duly possesses comparable powers and duties, (iv) an officer or an employee of any state contractor or prospective state contractor who has managerial or discretionary responsibilities with respect to a state contract, (v) the spouse or a dependent child who is eighten years of age or older of an individual described in this subparagraph, or (vi) a political committee established or controlled by an individual described in this subparagraph or the business entity or nonprofit organization that is the state contractor or prospective state contractor.

"State contract" means an agreement or contract with the state or any state agency of any quasi-public agency, let through a procurement process or otherwise, having a value of fifty thousand dollars or more, or a combination of services of such agreements or contracts having a value of one hundred thousand dollars or more in a calendar year, for (i) the rendition of services, (ii) the furnishing of any goods, material, supplies, equipment or any items of any kind, (iii) the construction, alteration or repair of any public building of public work, (iv) the acquisition, sale or lease of any land or building, (v) a licensing arrangement, or (vi) a grant, loan or loan guarantee. "State contract" floes not include any agreement or contract with the state, any state agency or any quasi-public agency that is exclusively federally funded, an education can, a loan to an individual for other than commercial purposes or any agreement or contract between the state or any state agency and the United States bepartment of the Navy or the United States Department of Defense.

"State contract solicitation" means a request by a state agency or vasi-public agency, in whatever form issued, including, but not limited to, an invitation to bid, request for proposals, request for information or request for dotes, inviting bids, quotes or other types of submittals, through a competitive procurement process or another process authorized by law waiving companies procurement.

"Managerial or discretionary responsibilities with respect to a state contract" means having direct, extensive and substantive responsibilities with respect to the negotiation of the state contract and not peripheral clerical or ministerial responsibilities.

"Dependent child" means a child residing in an individual's household who may legally be claimed as a dependent on the federal income tax return of such individual.

"Solicit" means (A) requesting that a contribution be made, (B) participating in any fundraising activities for a candidate committee, exploratory committee, political committee or party committee, including, but not limited to, forwarding tickets to potential contributors, receiving contributions for transmission to any such committee, serving on the committee that is hosting a fundraising event, introducing the candidate or making other public remarks at a fundraising event, being honored or otherwise recognized at a fundraising event, or bundling contributions, (C) serving as chairperson, treasurer or deputy treasurer of any such committee, or (D) establishing a political committee for the sole purpose of soliciting or receiving contributions for any committee. "Solicit" does not include (i) making a contribution that is otherwise permitted under this chapter, (ii) informing any person of a position taken by a candidate for public office or a public official, (iii) notifying the person of any activities of, or contact information for, any candidate for public office, (iv) serving as a member in any party committee or as an officer of such committee that is not otherwise prohibited in this subdivision, or (v) mere attendance at a fundraiser.

"Subcontractor" means any person, business entity or nonprofit organization that contracts to perform part or all of the obligations of a state contractor's state contract. Such person, business entity or nonprofit organization shall be deemed to be a subcontractor until December thirty-first of the year in which the subcontract terminates. "Subcontractor" does not include (i) a municipality or any other political subdivision of the state, including any entities or associations duly created by the municipality or political subdivision exclusively amongst themselves to further any purpose authorized by statute or charter, or (ii) an employee in the executive or legislative branch of state government or a quasi-public agency, whether in the classified or unclassified service and full or part-time, and only in such person's capacity as a state or quasi-public agency employee.

"Principal of a subcontractor" means (i) any individual who is a member of the board of directors of, or has an ownership interest of five per cent or more in, a subcontractor, which is a business entity, except for an individual who is a member of the board of directors of a nonprofit organization, (ii) an individual who is employed by a subcontractor, which is a business entity, as president, treasurer or executive vice president, (iii) an individual who is the chief executive officer of a subcontractor, which is not a business entity, or if a subcontractor has no such officer, then the officer who duly possesses comparable powers and duties, (iv) an officer or an employee of any subcontractor who has managerial or discretionary responsibilities with respect to a subcontract with a state contractor, (v) the spouse or a dependent child who is eighteen years of age or older of an individual described in this subparagraph, or (vi) a political committee established or controlled by an individual described in this subparagraph or the business entity or nonprofit organization that is the subcontractor.

CONNECTICUT HOUSING FINANCE AUTHORITY ETHICS STATEMENT

The Connecticut Housing Finance Authority ("CHFA") was created in 1969 by the State legislature as a quasi-public agency of the State of Connecticut. Its purpose is to help alleviate the shortage of affordable housing for low and moderate-income families and persons in Connecticut, and when appropriate, to promote or maintain the economic development of the State through employer-assisted housing efforts.

CHFA administers a multi-billion dollar portfolio of housing related financing in the State resulting primarily from its loan programs for both single and multifamily housing. These programs are financed by the proceeds of tax exempt and taxable bonds issued by CHFA together with State funds it administers and its own funds. CHFA has significant interaction with the State and private financial markets and has relationships with both nonprofit and for profit developers of housing. It is important that the CHFA Board of Directors and its employees and persons doing business or seeking to do business with CHFA understand and comply at all times with CHFA's ethical standards in the performance of their duties and conduct of their business.

It is the policy of the Connecticut Housing Finance Authority that its employees and members of its Board of Directors will comply with all laws and regulations pertaining to the conduct of CHFA's business and administration of its programs and that they will do so with the highest standards of ethical behavior. Those with whom CHFA does business are expected to similarly comply with applicable laws and regulations and standards. Any breach or deviation from applicable laws and regulations or standards will result in appropriate disciplinary action including but not limited to termination of employment and sanctions as required by CHFA and state law.

The CHFA Board of Directors and all CHFA employees are subject to the Code of Ethics for Public Officials, Connecticut General Statutes Chapter 10, Part 1, §§1-79 through 1-89 as amended ("Code of Ethics") in the discharge of their duties, including, but not limited to, the following provisions:

- Gifts In general, acceptance of gifts from anyone doing business with or seeking to do business with CHFA of from persons known to be a registered lobbyist or lobbyist's representative is prohibited
- Financial Benefit use of office for financial benefit of the individual, certain family members or associate nesses is prohibited
- Outside Employment outside employment which may impair independence of judgment or induct displosure of confidential information is prohibited (Note: Connecticut General Statutes § 8-244(b) provides notwithstanding the provisions of any other law to the contrary, it shall not constitute a conflict of interest for a trustee, director, partner or officer of any person, firm or corporation, or any individual having a financial interest in a person, firm or corporation, to serve as a member of the authority, provided such restee, director, partner, officer or individual shall abstain from deliberation, action or vote by the authority in specific respect to such person, then it corporation.)
- Financial Disclosure filing of financial disclosure statements with the State Ethics Con init ion is required by certain employees and the Board of Directors
- Post -State Employment accepting employment with parties to contracts or regular parties upon leaving CHFA is restricted (Note: Connecticut General Statutes § 1-84b(c) provides exceptions for members or former members of the boards or commissions who serve ex officio, who are required by statute to represent the regulated industry or who are permitted statute to have a past or present affiliation with the regulated industry.)

Members of the Board of Directors and all CHFA employees are provided a provisions of the CHFA employee handbook as amended ("Employee Handbook") including, but not limited to: of the Code of Ethics. Additionally, CHFA employees are subject to the

- Provisions limiting conflicts of interest and requiring filing fastatement with the President-Executive Director regarding any outside employment (§107)
- Requiring gifts with a value of \$10 to be returned or the cted to CHFA (§107)
- Prohibiting acceptance of meals or entertainment flow those in a position to benefit from CHFA decisions, contracts or financing (§107)

 Limitations on outside employment including conducting conducting outside business or employment during working hours or using CHFA facilities or resources to conduct any business offer than CHFA official business (§108)
- Requiring compliance with the Code of Ethics (§701)

Copies of this Ethics Statement, the Co Ethics and Employee Handbook are provided to employees and to each new employee prior to the commencement of employment with CHF. Employees are required to sign a statement acknowledging receipt of the Code of Ethics and Employee Handbook and agreeing to comply with their requirements.

Employees who leave CHFA are to comply with the Code of Ethics provisions regarding post-employment and are reminded of these during an exit interview with CHFA's Human resources staff.

Breaches of any of the provisions of the Code of Ethics or Employee Handbook or other governing laws or regulations will result in disciplinary action up to and including dismissal, in addition to sanctions provided by state law.

CHFA has designated as its Ethics Liaison its General Counsel. The Ethics Liaison is an available resource to CHFA employees regarding statutory and regulatory compliance and questions regarding ethical standards; however, questions concerning the applicability or enforcement of the Code of Ethics are to be directed to the State of Connecticut Ethics Commission.

Persons doing business with or seeking to do business with CHFA will be provided with a copy of this Ethics Statement and are required to comply with the applicable provisions of the Code of Ethics and the Code of Ethics for Lobbyists, Connecticut General Statutes §§1-91 through 1-101 and other governing laws and regulations including, but not limited to:

- Restrictions on gift giving (§1-84(f),(m))
- Employment(§1-84(g),1-84b(c)(3)
- Reporting(§1-84(o)

§ 4a-60. Nondiscrimination and affirmative action provisions in awarding agency, municipal public works and quasi-public agency project contracts

- (a) Except as provided in section 10a-151i, every contract to which an awarding agards a party, every quasi-public agency project contract and every municipal public works contract shall contain the following provisions:
- (1) The contractor agrees and warrants that in the performance of the contract such contractor will not discriminate or permit discrimination against any parson or group of persons on the grounds of race, color, religious creed, age, markal status, national origin, ancestry, sex, gender identity or expression, intellectual disability, mental disability or physical disability, including, but not limited to, blindness, where it is shown by such contractor that such disability prevents performance or the work involved, in any manner prohibited by the laws of the United States or of the state of Connecticut; and the contractor further agrees to take affirmative action to insure that applicants with job-related qualifications are employed and that employed are treated when employed without regard to their race, color, religious creed, age, marital status, national origin, ancestry, sex, gender identity or expression, intellectual disability, mental disability or physical disability, including, but not limited to, blindness, unless it is shown by such contractor that such disability prevents performance of the work involved;
- (2) The contractor agrees, a solicitations or advertisements for employees placed by or on behalf of the contractor to state that it is an "affirmative action-equal opportunity employer" in accordance with regulations adopted by the Commission on Human Rights and Opportunities;
- (3) The contractor agrees to provide each labor union or representative of workers with which such contractor has a collective bargaining agreement or other contract or understanding and each vendor with which such contractor has a contract or understanding, a notice to be provided by the Commission on Human Rights and Opportunities advising the labor union or workers' representative of the contractor's commitments under this section, and to post copies of the notice in conspicuous places available to employees and applicants for employment;
- (4) The contractor agrees to comply with each provision of this section and sections 46a-68e and 46a-68f and with each regulation or relevant order issued by said commission pursuant to sections 46a-56, 46a-68e, 46a-68f and 46a-86; and
- (5) The contractor agrees to provide the Commission on Human Rights and Opportunities with such information requested by the commission, and permit access to pertinent books, records and accounts, concerning the employment practices and procedures of the contractor as relate to the provisions of this section and section 46a-56.

- (b) If the contract is a public works contract, municipal public works contract or contract for a quasi-public agency project, the contractor agrees and warrants that he or she will make good faith efforts to employ minority business enterprises as subcontractors and suppliers of materials on such public works or quasi-public agency project.
- (c) Except as provided in section 10a-151:
- (1) Any contractor who has one or more contracts with an awarding agency or who is a party to a municipal public works contract or a contract for a quasi-public agency project, where any such contract is valued at less than fifty thousand dollars for each year of the contract, shall provide the awarding agency, or in the case of a municipal public works or quasi-public agency project contract, the Commission on Human Rights and Opportunities, with a written or electronic representation that complies with the nondiscrimination agreement and warranty under subdivision (1) of subsection (a) of this section, provided if there is any change in such representation, the contractor shall provide the updated representation to the awarding agency or commission not later than thirty days after such change.
- (2) Any contractor who has one or more contracts with an awarding agency or who is a party to a municipal public works contract or a contract for a quasi-public agency project, where any such contract is valued at fifty thousand dollars or more for any year of the

After the initial submission of such representation or documentation, the contractor shall not be required to resubmit such representation or documentation unless there is a change in the information contained in such representation or documentation. If there is any change in the information contained in the most recently filed representation or updated documentation, the contractor shall submit an updated representation or documentation, as applicable, either (A) not later than thirty days after the effective date of such change, or (B) upon the execution of a new contract with the awarding agency, municipality or entity, as applicable, whichever is earlier. Such contractor shall also certify, in accordance with subparagraph (B) or (C) of subdivision (2) of this subsection, to the awarding agency or commission, as applicable, not later than fourteen days after the twelve-month anniversary of the most recently filed representation, documentation or updated representation or documentation, that the representation on file with the awarding agency or commission, as applicable, is current and accurate.
- (d) For the purposes of this section, "contract" includes any extension or modification of the contract, "contractor" includes any successors or assigns of the contractor, "marital status" means being single, married as recognized by the state of Connecticut, widowed, separated or divorced, and "mental disability" means one or more mental disorders, as

defined in the most recent edition of the American Psychiatric Association's "Diagnostic and Statistical Manual of Mental Disorders", or a record of or regarding a person as having one or more such disorders. For the purposes of this section, "contract" does not include a contract where each contractor is (1) a political subdivision of the state, including, but not limited to, a municipality, unless the contract is a municipal public works contract or quasipublic agency project contract, (2) any other state, as defined in section 1-267, (3) the federal government, (4) a foreign government, or (5) an agency of a subdivision, state or government described in subdivision (1), (2), (3) or (4) of this subsection.

- (e) For the purposes of this section, "minority business enterprise" means any small contractor or supplier of materials fifty-one per cent or more of the capital stock, if any, or assets of which is owned by a person or persons: (1) Who are active in the daily affairs of the enterprise, (2) who have the power to direct the management and policies of the enterprise, and (3) who are members of a minority, as such term is defined in subsection (a) of section 32-9n; and "good faith" means that degree of diligence which a reasonable person would exercise in the performance of legal duties and obligations. "Good faith efforts" shall include, but not be limited to, those reasonable initial efforts necessary to comply with statutory or regulatory requirements and additional or substituted efforts when it is determined that such initial efforts will not be sufficient to comply with such requirements.
- (f) Determination of the contractor's good faith efforts shall include, but shall not be limited to, the following factors: The contractor's employment and subcontracting policies, patterns and practices; affirmative advertising, recruitment and training; technical assistance activities and such other reasonable activities or efforts as the Commission on Human Rights and Opportunities may prescribe that are designed to ensure the participation of minority business enterprises in public works projects.

No contract shall be awarded by the state or any of its political subdivisions to any person or firm or any firm, corporation, partnership or association in which such persons or firms have an interest (1) which has been cited for three or more wilful or serious violations of any occupational safety and health act or of any standard, order or regulation promuga pursuant to such act, during the three-year period preceding the bid, provided such violations were cited in accordance with the provisions of any state occupational safety and health act or the Occupational Safety and Health Act of 1970, 1 and not abate, within the time fixed by the citation and such citation has not been set aside following appeal to the appropriate agency or court having jurisdiction or (2) which has received one or more criminal convictions related to the injury or death of any employee the three-year period preceding the bid. 

Each such certification shall be sworn as true to the best knowledge and belief of the person signing the certification, subject to the penalties of false statement. If there is any change in the information contained in the most recently filed certification, such person shand ubmit an updated certification either (1) not later than thirty days after the effective five of any such change, or (2) upon the submittal of any new bid or proposal for a later state contract, whichever is earlier. Such person shall also submit to the state agency of quasi-public agency an accurate, updated certification not later than fourteen days after the twelvementh anniversary of the most recently filed certification or updated certification.
- (b) The official or employee of such state agency or quasi-tub c agency who is authorized to execute state contracts shall certify that the selection of the most qualified or highest ranked person, firm or corporation was not the result of collusion, the giving of a gift or the promise of a gift, compensation, fraud or inappropriate influence from any person.
- (c) Any principal or key personnel of the person, firm or corporation submitting a bid or proposal for a large state contract shall contract.
- (1) That no gifts were made by (A) soft person, firm, corporation, (B) any principals and key personnel of the person, firm or corporation, who participate substantially in preparing bids, proposals or negotiating state contracts, or (C) any agent of such person, firm, corporation or principals and key personnel, who participates substantially in preparing bids, proposals or negotiating state contracts, to (i) any public official or state employee of the state agency or quasi-public agency soliciting bids or proposals for state contracts, who participates substantially in the preparation of bid solicitations or requests for proposals for state contracts or the negotiation or award of state contracts, or (ii) any public official or state employee of any other state agency, who has supervisory or appointing authority over such state agency or quasi-public agency;
- (2) That no such principals and key personnel of the person, firm or corporation, or agent of such person, firm or corporation or principals and key personnel, knows of any action by the person, firm or corporation to circumvent such prohibition on gifts by providing for any other principals and key personnel, official, employee or agent of the person, firm or corporation to provide a gift to any such public official or state employee; and
- (3) That the person, firm or corporation is submitting bids or proposals without fraud or collusion with any person.
- (d) Any bidder or proposer that does not make the certification required under this section shall be disqualified and the state agency or quasi-public agency shall award the contract to the next highest ranked proposer or the next lowest responsible qualified bidder or seek new bids or proposals.

Prior to submitting a bid or proposal for a large state contract, each bidder or proposer who is an entity shalf submit a certification that such bidder or proposer has or has not made an investment as described in subsection (b) of this section.
- (d) Any entity who make a good faith effort to determine whether such entity has made an investment described in subsection (b) of this section shall not be subject to the penalties of false statement pursuant to this section. A "good faith effort" for purposes of this subsection includes a determination that such entity is not on the list of persons who engage in certain investment activities in Iran created by the Department of General Services of the state of California pursuant to Division 2, Chapter 2.7 of the California Public Contract Code. 2 Nothing in this subsection shall be construed to impair the ability of the state agency or quasi-public agency to pursue a breach of contract action for any violation of the provisions of the contract.
- (e) The provisions of this section shall not apply to any contract of the Treasurer as trustee of the Connecticut retirement plans and trust funds, as defined in section 3-13c, provided nothing in this subsection shall be construed to prevent the Treasurer from performing his or her fiduciary duties under section 3-13g.

- (A) There are other available remedies that the complainant can reasonably be expected to pursue:
- (B) The complaint is better suited for investigation or enforcement by another state agency;
- (C) The complaint is trivial, frivolous, vexatious or not made in good faith;
- (D) Other complaints have greater priority in terms of serving the public good;
- (E) The complaint is not timely or is too long delayed to justify further investigation; or
- (F) The complaint could be handled more appropriately as part of an ongoing or scheduled regular audit.

- (2) If the Auditors of Public Accounts reject a complaint pursuant to subdivision (1) of this subsection, the Auditors of Public Accounts shall provide a report to the Attorney General setting out the basis for the rejection.

- (2) (A) Not later than ninety days after learning of the specific incident giving rise to a claim that a personnel action has been threatened or has occurred in violation of subdivision (1) of this subsection, a state or quasi-public agency employee, an employee of a large state contractor or the employee's attorney may file a complaint against the state agency, quasipublic agency, Probate Court, large state contractor or appointing authority concerning such personnel action with the Chief Human Rights Referee designated under section 46a-57. Such complaint may be amended if an additional incident giving rise to a claim under this subdivision occurs subsequent to the filing of the original complaint. The Chief Human Rights Referee shall assign the complaint to a human rights referee appointed under section 46a-57, who shall conduct a hearing and issue a decision concerning whether the officer or employee taking or threatening to take the personnel action violated any provision of this section. The human rights referee may order a state agency, quasi-public agency or Probate Court to produce (i) an employee of such agency, quasi-public agency or Probate Court to testify as a witness in any proceeding under this subdivision, or (ii) books, papers or other documents relevant to the complaint, without issuing a subpoena. If such agency, quasi-public agency or Probate Court fails to produce such witness, books, papers or documents, not later than thirty days after such order, the human rights referee may consider such failure as supporting evidence for the complainant. If, after the hearing, the human rights referee finds a violation, the referee may award the aggrieved employee reinstatement to the employee's former position, back pay and reestablishment of any

employee benefits for which the employee would otherwise have been eligible if such violation had not occurred, reasonable attorneys' fees, and any other damages. For the purposes of this subsection, such human rights referee shall act as an independent hearing officer. The decision of a human rights referee under this subsection may be appealed by any person who was a party at such hearing, in accordance with the provisions of section 4-183.

- (B) The Chief Human Rights Referee shall adopt regulations, in accordance with the provisions of chapter 54, 1 establishing the procedure for filing complaints and noticing and conducting hearings under subparagraph (A) of this subdivision.
- (3) As an alternative to the provisions of subdivision (2) of this subsection: (A) A state or quasi-public agency employee who alleges that a personnel action has been threatened or taken may file an appeal not later than ninety days after learning of the specific incident giving rise to such claim with the Employees' Review Board under section 5-202, or, in the case of a state or quasi-public agency employee covered by a collective bargaining contract, in accordance with the procedure provided by such contract; or (B) an employee of a large state contractor alleging that such action has been threatened or taken may, after exhausting all available administrative remedies, bring a civil action in accordance with the provisions of subsection (c) of section 31-51m.
- (4) In any proceeding under subdivision (2) or (3) of this subsection concerning a personnel action taken or threatened against any state or quasi-public agency employee or any employee of a large state contractor, which personnel action occurs not later than two years after the employee first transmits facts and information concerning a matter under subsection (a) of this section or discloses information under subdivision (1) of this subsection to the Auditors of Public Accounts, the Attorney General or an employee of state agency, quasi-public agency or Probate Court, as applicable, there shall be a rebuttable presumption that the personnel action is in retaliation for the action taken by employee under subsection (a) of this section or subdivision (1) of this subsection
- (5) If a state officer or employee, as defined in section 4-141, a quasi-public or employee, an officer or employee of a large state contractor or an appointing authority takes or threatens to take any action to impede, fail to renew or carcel a contract between a state agency and a large state contractor, or between a large state contractor and its subcontractor, in retaliation for the disclosure of information porsuant to subsection (a) of this section or subdivision (1) of this subsection to any age of listed in subdivision (1) of this subsection, such affected agency, contractor or subcontractor may, not later than ninety days after learning of such action, threat or failure tenew, bring a civil action in the superior court for the judicial district of Hartford Decover damages, attorney's fees and costs.
- (f) Any employee of a state agency, quari-public agency, Probate Court or large state contractor, who is found by the Auditors of Public Accounts, the Attorney General, a human rights referee or the Employees Review Board to have knowingly and maliciously made false charges under subsection, a) of this section, shall be subject to disciplinary action by such employee's appointing adthority up to and including dismissal. In the case of a state or quasi-public agency employee, such action shall be subject to appeal to the Employees' Review Board in accordance with section 5-202, or in the case of state or quasi-public agency employees included in collective bargaining contracts, the procedure provided by such contracts.
- (g) On or before September first, annually, the Auditors of Public Accounts shall submit, in accordance with the provisions of section 11-4a, to the clerk of each house of the General Assembly a report indicating the number of matters for which facts and information were transmitted to the auditors pursuant to this section during the preceding state fiscal year and the disposition of each such matter.
- (h) Each contract between a state or quasi-public agency and a large state contractor shall provide that, if an officer, employee or appointing authority of a large state contractor takes or threatens to take any personnel action against any employee of the contractor in retaliation for such employee's disclosure of information to any employee of the contracting state or quasi-public agency or the Auditors of Public Accounts or the Attorney General under the provisions of subsection (a) or subdivision (1) of subsection (e) of this section, the contractor shall be liable for a civil penalty of not more than five thousand dollars for each offense, up to a maximum of twenty per cent of the value of the contract. Each violation shall be a separate and distinct offense and in the case of a continuing violation each calendar day's continuance of the violation shall be deemed to be a separate and

distinct offense. The executive head of the state or quasi-public agency may request the Attorney General to bring a civil action in the superior court for the judicial district of Hartford to seek imposition and recovery of such civil penalty.

- (i) Each state agency or quasi-public agency shall post a notice of the provisions of this section relating to state employees and guasi-public agency employees in a conspicuous place that is readily available for viewing by employees of such agency or quasi-public agency. Each Probate Court shall post a notice of the provisions of this section relating to Probate Court employees in a conspicuous place that is readily available for viewing by employees of such court. Each large state contractor shall post a notice of the provisions of this section relating to large state contractors in a conspicuous place which is readily available for viewing by the employees of the contractor.
- (i) No person who, in good faith, discloses information in accordance with the provisions of this section shall be liable for any civil damages resulting from such good faith disclosure.
- (k) As used in this section:
- (1) "Large state contract" means a contract between an entity and a state or quasi-public agency, having a value of five million dollars or more; and
- (2) "Large state contractor" means an entity that has entered into a large state contract with a state or quasi-public agency.
- (I) No officer or employee of a state shellfish grounds lessee shall take or threaten to take any personnel action against any employee of a state shellfish grounds lessee in retaliation for (A) such employee's disclosure of information to an employee of the leasing agency concerning information involving the state shellfish grounds lease, or (B) such employee's testimony or assistance in any proceeding under this section.
- (2) (A) Not later than ninety days after learning of the specific incident giving rise that a personnel action has been threatened or has occurred in violation of so of this subsection, an employee of a state shellfish grounds lessee or the phylogee's attorney may file a complaint against the state shellfish grounds lessee concerning such personnel action with the Chief Human Rights Referee designated under section 46a-57. Such complaint may be amended if an additional incident giving lise to a claim under this subdivision occurs subsequent to the filing of the original compaint. The Chief Human Rights Referee shall assign the complaint to a human rights referee appointed under section 46a-57, who shall conduct a hearing and issue a decision concerning whether the officer or employee taking or threatening to take the personnel action violated any provision of this subsection. The human rights referee pray order a state shellfish grounds lessee to produce (i) an employee of such lessee to testify as a witness in any proceeding under this subdivision, or (ii) books, papers or other coordinates relevant to the complaint, without issuing a subpoena. If such state shellish grounds lessee fails to produce such witness, books papers or documents, not like the thirty down of the such sides the human rights. books, papers or documents, not later than thirty days after such order, the human rights referee may consider such failures supporting evidence for the complainant. If, after the hearing, the human rights referee finds a violation, the referee may award the aggrieved employee reinstatement to the employee's former position, back pay and reestablishment of any employee benefits for which the employee would otherwise have been eligible if such violation had not occurred, reasonable attorneys' fees and any other damages. For the purposes of this subsection, such human rights referee shall act as an independent hearing officer. The decision of a human rights referee under this subsection may be appealed by any person who was a party at such hearing, in accordance with the provisions of section 4-183.
